### 3. Participation

### 3.1 Eligibility.

 Participation in biding is open to all legal persons having registered business entity including sole proprietorship, Association of Persons (AOP), partnership firm, private or public limited companies having valid NTN registration. Individual Supplier/Contractor would not eligible to participate in this bid.

### 3.2 Exclusion from participation.

Supplier/Contractors must have to certify in a declaration that they are not in one of the following situation

- They are bankrupt or being wound up, are having their affairs administered by the
  courts, have entered into an arrangement with creditors, have suspended business
  activities, are the subject of proceedings concerning those matters, or are in any
  analogous situation arising from a similar procedure provided for in national
  legislation or regulations;
- They have been convicted of an offence concerning their professional conduct by a judgment;
- They have been guilty of grave professional misconduct proven by any means;
- They have not fulfilled obligations relating to the payment of social security
- Contributions or the payment of taxes in accordance with the legal provisions of

- country where the contract to be performed.
- They have been subject of a judgment which has the force of res judicata for fraud, corruption, involvement in a criminal organization or any other illegal activity detrimental to the communities' financial interest

### 3.3 Exclusion from award of contract

Contracts may not be awarded to bids which during the procurement procedure:

- (a) Are subject to a conflict of interest;
- (b) Are guilty of misrepresentation in supplying the information required as a condition of participation in the contract procedure or fail to supply this information.
- 3.4 These terms refer to all nationals of the above states and to all legal entities, companies or partnerships effectively established in the above states. For the purposes of proving compliance with this rule, Supplier/Contractors being legal persons, must present the documents required under that country's law.
- 3.5 The eligibility requirement detailed in sub clauses 3.1 and 3.2 applies to all members of a joint venture/consortium and all subcontractors, as well as to all entities upon whose capacity the Supplier/Contractor relies for the selection criteria. Every Supplier/Contractor, member of a joint venture/consortium, every capacity-providing entity, and every subcontractor providing more than 10 % of the supplies must certify that they meet these conditions. They must prove their eligibility by a document dated less than one year earlier than the deadline for submitting bids, drawn up in accordance with their national law or practice or by copies of the original documents stating the constitution and/or legal status and the place of registration and/or statutory seat and, if it is different, the place of central administration. The NRSP may accept other satisfactory evidence that these conditions are
- To be eligible to take part in this bid procedure, Supplier/Contractors must prove to the satisfaction of the NRSP that they comply with the necessary legal, technical and financial requirements and have the means to carry out the contract effectively.
- 3.7 Where bids include subcontracting, it is recommended that the contractual arrangements between Supplier/Contractors and their subcontractors include mediation, according to national and international practices, as a method of dispute resolution.

### 4. Origin

4.1 All supplies/vehicles under this contract may originate from any country.

### 5. Type of contract

### 6. Currency

### 7. Lots

This bid evaluation will be made lot wise. The bids can apply for one or more than one lots.

### 8. Period of validity

- 8.1 Supplier/Contractors will be bound by their bids for a period of 60 days from the deadline for the submission of bids. Quoted price shall be fix till September, 2024 and would not be increased in any case.
- 8.2 In exceptional cases and prior to the expiry of the original bid validity period, the NRSP may ask Supplier/Contractors in writing to extend this period by 30 days. Such requests and the responses to them must be made in writing. Supplier/Contractors that agree to do so will not be permitted to modify their bids and they are bound to extend the validity of their bid security for the revised period of validity of the bid. If they refuse, without forfeiture of their bid security, their participation in the bid procedure will be terminated.
- 8.3 The successful Supplier/Contractor will be bound by its bid for a further period of 60 days. The further period is added to the validity period of the bid irrespective of the date of notification.

### 9. Language of bids

9.1 The bids, all correspondence and documents related to the bid exchanged by the Supplier/Contractor and the NRSP must be written in the language of the procedure, which is English.

### 12. Rejection of Bid

### 13. Taxes and other charges

- The quoted rates should be inclusive of all applicable taxes (WHT & SST) as per law of land. In case of any exemption Supplier/Contractors should have to provide a valid exemption certificate as per government rules. Applicable tax would be deducted from each and every payment as per applicable law. Tax deduction certificate would be provided within 6 week from the date of payment.
- Supplier/Contractors must have to provide the comprehensive insurance of the vehicles offered. Copy of insurance policy need to submit for the contract by the shortlisted Supplier/Contractor.
- The quoted prices should be included of all transportation, carriage, handling and all other costs.

### 14. Additional information before the deadline for submission of bids

The bid package is clear that Supplier/Contractors do not need to request additional information during the procedure. Any prospective Supplier/Contractors seeking to arrange individual meetings with either the NRSP and/or the European Commission during the bid period may be excluded from the bid procedure.

### 15. Alteration or withdrawal of bids

- 15.1 Supplier/Contractors may alter or withdraw their bids by written notification prior to the deadline for submission of bids referred to in Article 10.1. No bid may be altered after this deadline. Withdrawals must be unconditional and will end all participation in the bid procedure.
- 15.2 Any such notification of alteration or withdrawal must be prepared and submitted in accordance with Article 10. The outer envelope must be marked 'Alteration' or 'Withdrawal' as appropriate.
- 15.3 No bid may be withdrawn in the interval between the deadline for submission of bids referred to in Article 10.1 and the expiry of the bid validity period. Withdrawal of a bid during this interval may result in forfeiture of the bid security.

### 16. Cost of preparing bids

No costs incurred by the Supplier/Contractor in preparing and submitting the bid are reimbursable. All such costs will be borne by the Supplier/Contractor.

### 17. Ownership of bids

The NRSP retains ownership of all bids received under this bid procedure. Consequently, Supplier/Contractors have no right to have their bids returned to them.

### 18. Opening of bids

18.1 The opening and examination of bids is for the purpose of checking whether the bids are complete, whether the requisite bid security have been furnished, whether the required documents have been properly included and whether the bids are generally in order.

- 18.2 At the bid opening, the Supplier/Contractors' names, the bid prices, any discount offered, may be announced.
- 18.3 After the public opening of the bids, no information relating to the examination, clarification, evaluation and comparison of bids, or recommendations concerning the award of the contract can be disclosed until after the contract has been awarded.
- 18.4 Any attempt by Supplier/Contractors to influence the evaluation committee in the process of examination, clarification, evaluation and comparison of bids, to obtain information on how the procedure is progressing or to influence the NRSP in its decision concerning the award of the contract will result in the immediate rejection of their bids.
- 18.5 All bids received after the deadline for submission specified in the contract notice or these instructions will be kept by the NRSP. The associated guarantees will be returned to the Supplier/Contractors. No liability can be accepted for late delivery of bids. Late bids will be rejected and will not be evaluated.

### 19. Evaluation of bids

19.1 Examination of the administrative conformity of bids

The aim at this stage is to check that bids comply with the essential requirements of the bid dossier. A bid is deemed to comply if it satisfies all the conditions, procedures and specifications in the bid dossier without substantially departing from or attaching restrictions to them.

Substantial departures or restrictions are those which affect the scope, quality or execution of the contract, differ widely from the terms of the bid dossier, limit the rights of the NRSP or the Supplier/Contractor's obligations under the contract or distort competition for

Supplier/Contractors whose bids do comply. Decisions to the effect that a bid is not administratively compliant must be duly justified in the evaluation minutes.

If a bid does not comply with the bid dossier, it will be rejected immediately and may not subsequently be made to comply by correcting it or withdrawing the departure or restriction.

### 19.2 Technical evaluation

After analyzing the bids deemed to comply in administrative terms, the evaluation committee will rule on the technical admissibility of each bid, classifying it as technically compliant or non-compliant.

19.3 In the interests of transparency and equal treatment and to facilitate the examination and evaluation of bids, the evaluation committee may ask each Supplier/Contractor individually for clarification of its bid including breakdowns of prices, within a reasonable time limit to be fixed by the evaluation committee. The request for clarification and the response must be in writing, but no change in the price or substance of the bid may be sought, offered or permitted except as required to confirm the correction of arithmetical errors discovered during the evaluation of bids. Any such request for clarification must not distort competition. Decisions to the effect that a bid is not technically compliant must be duly justified in the evaluation minutes.

### 19.4 Financial evaluation

- a) Bids found to be technically compliant will be checked for any arithmetical errors in computation and summation. Errors will be corrected by the evaluation committee as follows:
  - where there is a discrepancy between amounts in figures and in words, the amount in words will be the amount taken into account;
  - Except for lump-sum contracts, where there is a discrepancy between a unit price and the total amount derived from the multiplication of the unit price and the quantity, the unit price as quoted will be the price taken into account.
- b) Amounts corrected in this way will be binding on the Supplier/Contractor. If the Supplier/Contractor does not accept them, its bid will be rejected.

### 19.5 Award criteria

- The sole award criterion will be the required/given technical specification and price.
- Lowest price will not be the sole criteria; condition of vehicles and delivery time will be considered.
- NRSP reserve the right for conducting inspection by its own personnel or reputed third parties of the offered vehicles. The selected Supplier/Contractor has to offer the items for inspection in such a manner that it does not affect the delivery schedule.
- NRSP reserve the right to split the contact between two or more Supplier/Contractor as per received offers lot wise.

The technically compliant bid that offers the best price-quality ratio will be chosen.

### 20. Signature of the contract and performance guarantee

20.1 The successful Supplier/Contractor will be informed in writing that its bid has been accepted (notification of award). Before the NRSP signs the contract with the successful Supplier/Contractor, the successful Supplier/Contractor must provide the **documentary proof** (original copies), including company incorporation/registration, experience certificates, financial accounts, NTN Certificate, bank statement or any other document needed by the evaluation committee according to the selection criteria.

- 20.2 The successful Supplier/Contractor must also provide evidence of financial and economic standing and technical and professional capacity according to the selection criteria within 5 working days following the notification award or if the successful Supplier/Contractor is found to have provided false information or fake documents, the award will be considered null and void. In such case the NRSP may award the bid to the nest lowest Supplier/Contractor or cancel the bid procedure.
- 20.4 The NRSP reserves the right to vary quantities specified in the bid by +/- 15 % at the time of contracting and during the validity of the contract. The total value of the supplies may not, as a result of the variation rise or fall by more than 25 % of the original financial offer in the bid. The unit prices quoted in the bid shall be used.
- 20.5 Within 14 days receipt of the contract signed by the NRSP, the selected Supplier/Contractor must sign and date the contract and return it, with the performance guarantee (if applicable), to the NRSP. On signing the contract, the successful Supplier/Contractor will become the Contractor and the contract will enter into force.
- 20.6 If it fails to sign and return the contract and any financial guarantee required within 14 days after receipt of notification, the NRSP may consider the acceptance of the bid to be cancelled without prejudice to the NRSP's right to seize the guarantee, claim compensation or pursue any other remedy in respect of such failure, and the successful Supplier/Contractor will have no claim whatsoever on the NRSP.

### 21. Bid Security (Earnest Money)

The Bid security (earnest money) for Rs.20, 000/- (Rupees twenty thousand only) per lot in shape of demand draft/pay order/call deposit in the name of NRSP. NRSP NTN is 0656952-8.

### 22. Ethics clauses

- 22.1 Any attempt by a candidate or Supplier/Contractor to obtain confidential information, enter into unlawful agreements with competitors or influence the committee or the NRSP during the process of examining, clarifying, evaluating and comparing bids will lead to the rejection of their candidacy or bid and may result in administrative penalties.
- 22.2 Without the NRSP's prior written authorization, a Contractor and its staff or any other company with which the Contractor is associated or linked may not, even on an ancillary or subcontracting basis, supply other services, carry out works or supply equipment for the project. This prohibition also applies to any other projects that could, owing to the nature of the contract, give rise to a conflict of interest on the part of the Contractor.
- 22.3. When submitting a bid, Supplier/Contractors must declare that they are not affected by a conflict of interest and have no equivalent relation in that respect with other Supplier/Contractors or parties involved in the project. Should such a situation arise during execution of the contract, the Contractor must immediately inform the NRSP.
- 22.4 Contractors must at all times act impartially and as faithful advisers in accordance with the code of conduct of their profession. They will refrain from making public statements about the project or services without the NRSP's prior approval. They may not commit the NRSP in any way without its prior written consent.
- 22.5 For the duration of the contracts Contractors and their staff must respect human rights and undertake not to offend the political, cultural and religious mores of the beneficiary state. In particular and in accordance with the legal basic act concerned, Supplier/Contractors that have been awarded contracts must abide by core labour standards as defined in the relevant International Labour Organization conventions (such as the Conventions on freedom of association and collective bargaining; Abolition of forced and compulsory Labour; Elimination

- of forced and compulsory labour; Abolition of child labour).
- 22.6 Contractors may accept no payment connected with the contracts other than that provided for therein. Contractors and their staff must not exercise any activity nor receive any advantage inconsistent with their obligations to the NRSP.
- 22.7 Contractors and their staff are obliged to maintain professional secrecy for the entire duration of contracts and after their completion. All reports and documents drawn up or received by Contractors will be confidential.
- 22.8 The contract governs the Contracting Parties' use of all reports and documents drawn up, received or presented by them during the implementation of the contract.
- 22.9 Contractors must refrain from any relationship likely to compromise their independence or that of their staff. If the Contractor ceases to be independent, the NRSP may, regardless of injury, terminate the contract without further notice and without the Contractor having any claim to compensation.
- 22.10 The Commission reserves the right to suspend or cancel project financing if corrupt practices of any kind are discovered at any stage of the award process and if the NRSP fails to take all appropriate measures to remedy the situation. For the purposes of this provision, 'corrupt practices' are the offer of a bribe, gift, gratuity or commission to any person as an inducement or reward for performing or refraining from any act relating to the award of a contract or implementation of a contract already concluded with the NRSP.
- 22.11 All bids will be rejected or contracts terminated if it emerges that the award or implementation of a contract has given rise to unusual commercial expenses. Such unusual commercial expenses are commissions not mentioned in the main contract or not stemming from a properly concluded contract referring to the main contract, commissions not paid in return for any actual and legitimate service, commissions remitted to a tax haven, commissions paid to a recipient who is not clearly identified or commissions paid to a company which has any appearance of being a front company.
- 22.12 The Contractor undertakes to supply the Commission on request with all supporting documents relating to the conditions of the contract's execution. The Commission may carry out whatever documentary or on-the-spot checks it deems necessary to find evidence in cases of suspected unusual commercial expenses.

  Contractors found to have paid unusual commercial expenses on projects funded by the NSER are liable, depending on the seriousness of the facts observed, to have their contracts terminated or to be permanently excluded from receiving NSER funds.
- 22.13 The NRSP reserves the right to suspend or cancel the procedure, if the award procedure proves to have been subject to substantial errors, irregularities or fraud. Where such substantial errors, irregularities or fraud are discovered after the award of the Contract, the NRSP may refrain from concluding the Contract.

### 23. Cancellation of the bid procedure

If a bid procedure is cancelled, Supplier/Contractors will be notified by the NRSP. If the bid procedure is cancelled before the bid opening session the sealed envelopes will be returned, unopened, to the Supplier/Contractors.

Cancellation may occur, for example, if:

- the bid procedure has been unsuccessful, namely where no suitable, qualitatively or financially acceptable bid has been received or there has been no valid response at all;
- the economic or technical parameters of the project have changed fundamentally;

- exceptional circumstances or *force majeure* render normal implementation of the project impossible;
- all technically acceptable bids exceed the financial resources available;
- there have been substantial errors, irregularities or frauds in the procedure, in particular where these have prevented fair competition;
- the award is not in compliance with sound financial management, i.e. does not respect the principles of economy, efficiency and effectiveness (e.g. the price proposed by the Supplier/Contractor to whom the contract is to be awarded is objectively disproportionate with regard to the price of the market.

In no event will the NRSP be liable for any damages whatsoever including, without limitation, damages for loss of profits, in any way connected with the cancellation of a bid procedure even if the NRSP has been advised of the possibility of damages. The publication of a contract notice does not commit the NRSP to implement the programme or project announced.

### 24. Penalty

- The NRSP reserve the right to forfeit the bid security (earnest money) in case the successful Supplier/Contractor regrets or fail to provide the vehicles.
- In case of down time of any/all the rental vehicles NRSP will arrange its how hired vehicles and all expenses will be deducted from the Supplier/Contractor as per actual till the time of replacement of down vehicles received.

### 25. Appeals

Supplier/Contractors believing that they have been harmed by an error or irregularity during the award process may file a complaint to NRSP at complaints@nrsp.org.pk.
