1. Introduction

Established in 1991, NRSP is the largest Rural Support Programme in the country in terms of outreach, staff and development activities. It is a not for profit organization registered under Section 42 of Companies Ordinance 1984.

NRSP's mandate is to alleviate poverty by harnessing people's potential and undertake development activities in Pakistan. It has a presence in 56 Districts in all the four Provinces including Azad Jammu and Kashmir through Regional Offices and Field Offices. NRSP is currently working with more than half a million poor households organized into a network of more than 115,076 Community Organizations. With sustained incremental growth, it is emerging as Pakistan's leading engine for poverty reduction and rural development.

2. Background

NRSP is implementing the project titled as "Expanding Support to Malaria Control Interventions in High Priority Districts of Pakistan" with the financial assistance of Global Fund to Fight AIDS, Tuberculosis and Malaria (GFATM). The project is being implemented nationwide and there is a need to different Chemical Regents and laboratory Items.

3. Procurement details.

4. Submission of Bid

- a. Bids with specifications, make, brand and rates of the offered items should be submitted in the one single sealed envelope. Complete make of each items should be mentioned on the bid.
- b. **Samples will be called from shortlisted suppliers at later stage. In case supplier fails to submit the samples on the date, time and venue, his bid will be rejected. Sample will be required at NRSP HO, Islamabad.**
- c. Prices should be inclusive of all applicable taxes and transportation must be mentioned clearly.
- d. Prices shall include packing, transportation, loading/unloading, till the destination which is **Hyderabad Sindh**.
- e. The Bidders should take care in submitting the bid and ensure that enclosed papers are not found loose and should be **properly numbered** and submitted in a file in proper manner so that the papers do not bulge out and tear during scrutiny.

- i. Offer your best prices as there will be **NO price negotiation** after opening of the bids.
- j. The purchaser reserves the right for conducting pre-shipment inspection by its own personnel or reputed third parties. The selected bidder has to offer the items for inspection in such a manner that it does not affect the delivery schedule.
- k. The offer should remain **valid for a period of 60 days** from the closing date of the Commercial Bid. Any offer falling short of the validity period is liable for rejection. If a bidder extends bid validity period, then will also extend the bid security period.
- l. Selected bidder must undertake to provide the purchaser, the consignment notes number(s) by which the item ordered had been dispatched from their site, so as to have online / web access to the tracking system of physical movement of the consignments sent through courier.
- m. The vendor may withdraw its offer after its submission, provided that written notice of withdrawal is received by the purchaser prior to the closing date and time prescribed for submission of tender documents. No offer can be withdrawn by the vendor subsequent to the closing date and time for submission of offers.

5. Eligibility of the Bidder

Below is the eligibility criteria for this tender.

- a. Suppliers must have valid and active NTN & GST registration (copies to be attached)
- b. Supplier must be an active tax payer as per FBR portal on the date of submission of bids (proof to be attached).
- c. Supplier must have previous experience in the supply of Giemsa Stain, Immersion Oil, Methanol and other items (proof to be attached in the shape of verifiable Purchase Orders/Contracts, especially for Giemsa Stain, Immersion Oil and Methanol).
- d. Any supplier having bad previous experience with NRSP would not be eligible.

e. Declaration of eligibility as per Annex A (on Rs.100 Stamp paper) dully attested by notary public.

6. Deliverables

Chemical, regent and other laboratory items as per details given section 3.

7. Terms of Bid

a. Bid Security

All bidders shall furnish Security Deposit equivalent to **2% of the Cost of Deliverables (total bid value)** in the form of Call deposit/Pay Order/Demand Draft in favor of NRSP. Cheque will not be accepted in any case. After selection of successful bidder, NRSP will return/release the bid security to the unsuccessful bidders.

b. Performance Security

Successful supplier has to submit the performance security which would be **10%** of the total order within 7 days of issuance of PO. Bid security of successful supplier can be adjusted in performance security. Performance security will be released after the completion of delivery to all the locations.

8. Submission of Bid and required Documents

a. The Bid should comply with the specification, make, brand of required the Chemical & Tablets specified in section 3. The offer should be complete in all respects and contain all information asked for, with prices The Technical Bid must be organized neatly and securely in the following manner.

- i. Covering letter
- ii. Copy of Valid and active NTN & GST Certificate.
- iii. Filer status as per FBR portal
- iv. Previous Experience proof in the shape of purchaser order or contract with contact details.
- v. Technical and Financial proposal with technical details, make and brand with terms and conditions. (on supplier letterhead dully signed and stamped)
- vi. Certificate of Analysis of Giemsa Stain, Immersion Oil and Methanol.
- vii. Declaration of eligibility as per Annex A (on supplier letterhead)
- viii. Others, if any.

b. **If the Bid is not submitted in the prescribed formats or any of the item in the as mentioned above, the Bid is liable for outright rejection. All the required documents must be attached/provided.**

c. Once the bid is submitted in sealed cover by the bidder, the purchaser will not accept any addition / alterations / deletions of the Bid. However, the purchaser reserves the right to seek clarification or call for supporting documents from any of the bidders, for which the concerned bidder will need to submit the documentary evidence(s) as required by the purchaser.

d. Any Bid, submitted with incorrect information will be liable for rejection. Further, if any bidder is found to have submitted incorrect information at any time, he may be debarred from participation in the future tendering processes.

9. Sampling

Pre delivery sampling:

Samples for all the items would be called from technically qualified and financial lowest bidder(s) for quality checking and lab test (lab test would be done for Giemsa, Immersion Oil and Methanol only from the project recommended Government lab only in Sindh). PO will be issued only after the quality checking and successful lab test results. Purchaser may send the samples to company or any authorized representative for endorsing that this product is genuine (specially for Giemsa, Immersion Oil and Methanol).

Post delivery sampling:

Supplier has to make sure that same items, batch to be delivered which is submitted for pre delivery inspection and sampling. After the delivery at Hyderabad, our team will take random samples of Giemsa, Immersion Oil and Methanol for lab testing and rest of the items will be matched as per submitted & approved samples. If delivered chemicals lab test are same which are obtained from pre delivery samples and quality of other items are same as per approved samples, delivery will be accepted and payment will be processed. If chemicals do not pass the lab test with same results which are obtained from pre delivery samples and other items not as per submitted samples, delivery will be rejected and supplier need to pick-up the Chemical, regent and other

laboratory items from delivery location at his own cost. (this process may take 2-3 weeks). In such supplier may be blacklisted by Purchaser.

The supplier must ensure that the batch/lot number of the chemicals (Giemsa, Immersion Oil and Methanol) supplied is same as the batch/lot number of the approved pre-delivery sample. Any deviation in batch/lot number without prior written approval of NRSP shall result in rejection of the entire consignment, and the supplier will be responsible for replacement at their own cost.

The supplier shall clearly mention the batch/lot number, manufacturing date, and expiry date in the delivery documents and on the invoice.

10. Evaluation Criteria for Bid

- a. The Purchaser will scrutinize the offers to determine whether it is complete, whether errors have been made in the offer, whether required technical documentation has been furnished and whether the documents have been properly signed. Offers with incorrect information or not supported by documentary evidence, wherever called for, would be summarily rejected. However, the purchaser, at its sole discretion, may waive any minor non-conformity or any minor irregularity in an offer. The Purchaser reserves the right for such waivers and this shall be binding on all vendors.
- b. Evaluation and Award criteria will be Eligibility, quality of Samples & Lab test and lowest price.
- c. NRSP reserve the right to split the order be two or more suppliers.
- d. For proper scrutiny, evaluation and comparison of offers, the purchaser may, at its discretion, ask some or all vendors for clarification of their offer. The request for such clarifications and the response will necessarily be in writing.

11. Fees and payment Schedule

- a. No Advance will be allowed in any case.
- b. Payment will be made after the complete and satisfactory delivery/acceptance of the Chemical and Tablets to the designated delivery site/destinations within 3-4 weeks through cross cheque.
- c. Applicable taxes (WTH and GST) will be deducted from all the invoices as per prescribed law of Govt. of Pakistan. Tax challan will be provided within 3-4 weeks of the payment.

12. Paying Authority

The payments as per the Payment Schedule covered hereinabove shall be paid by NRSP. However, Payment of the Bills would be payable on receipt of advice/confirmation for satisfactory delivery from, Project coordinator Directorate of Malaria Control project.

Following Documents are to be submitted for Payment:

- a) Bill
- b) GST Invoice
- c) Duly acknowledged Delivery Challan.

13. Delivery Schedule

- a. The Selected Bidder must undertake to deliver the Chemical, reagent and other laboratory items ordered, to location/office at Hyderabad, Sindh within the time offered in the bids from the date of the Purchase Order. Complete delivery details will be provided at the time of order. However, Delivery schedule may be changed under special circumstances at the discretion of the Purchaser.
- b. The delivery of Chemical, reagent and other laboratory items will be delivered at Hyderabad, Sindh.

14. Warranty & Maintenance

The Vendor shall be fully responsible for the defected/rejected/breakage of Chemical, reagent and other laboratory items and will be responsible to replace at his own cost within in two weeks.

15. Penalty for Downtime

In case of delay in the supply of material against the terms indicated in the purchase order, the Vendor will have to pay a fine of 0.5 % (Half) percent of the balance qty for each day of delay. If shipment is delayed

for more than 15 days, the Purchaser has the right to unilaterally cancel the contract and his bid security will be forfeited.

16. Penalty On Liquidated Damages for delayed supply

In case the delivery is delayed beyond the stipulated date of delivery, 'Liquidated damage for late delivery @ one half of one percent (0.5%) of the order value for each day of delay or part thereof would be imposed, subject to maximum of 10% if the delay is for 10 days or more. The penalty for late delivery will be deducted from the bill amount.

17. Bid Currency

All prices shall be expressed in Pakistani Rupees only.

18. Cost of Bidding

The bidder shall bear all the costs associated with the preparation and submission of bids & samples and NRSP will in no case be responsible or liable for these costs regardless of the conduct or outcome of the bidding process.

19. Bidding Document

The bidder is expected to examine all instructions, forms, Terms and Conditions and specifications in the Bidding Document. Submission of a bid not responsive to the Bidding Document in every respect will be at the bidder's risk and may result in the rejection of its bid without any further reference to the bidder.

20. Deadline for Submission of Bids

Bids must be received by the Purchaser at the address specified in the Bid Document not later than the specified date and time as specified in the Bid Document. In the event of the specified date of submission of bids being declared a holiday for the Purchaser, the bids will be received up to the appointed time on next working day.

The Purchaser may, at its discretion, extend this deadline for submission of bids by amending the bid documents.

21. Confidentiality Statement

All data and information received from NRSP for the purpose of this assignment is to be treated confidentially and is to be used ONLY in connection with the execution of these Terms of Reference. All intellectual property rights arising from the execution of these Terms of Reference are assigned to NRSP. The contents of written materials obtained and used in this assignment may not be disclosed to any third parties without the expressed advance written authorization of NRSP.

NRSP may then disclose the draft, final report and/or any related information to any person and for any purpose they may deem appropriate.

22. General Terms & Conditions

- a. The Purchaser does not bind itself to accept the lowest or any Bid and reserves the right to reject any or all Bids at any point of time prior to the issuance of purchase order without assigning any reasons whatsoever.
- b. NRSP may increase or decrease the quantities up to 25% at the time of final ordering.
- c. NRSP have the right to split the order in two or more suppliers depending upon the rates/items being shortlisted.
- d. The NRSP reserves the right to resort to re-tendering without providing any reason whatsoever. The NRSP shall not incur any liability on account of such rejection.
- e. The NRSP reserves the right to modify any terms, conditions or specifications for submission of offer and to obtain revised Bids from the bidders due to such changes, if any.
- f. Canvassing of any kind will be a disqualification and the NRSP may decide to cancel the bidder from its empanelment.
- g. Supplier code of conduct is attached for required compliance as Annex B.

23. Rejection of the Bid

The Bid is liable to be **rejected** if:

- a. The document doesn't bear signature of authorized person.
- b. It is received through E-mail.
- c. If the bid does not have any make, brand or other details of offered items.

- d. If the supplier fails to submit the Certificate of Analysis with the bid.
- e. If the supplier fails to submit the sample on the required date, time and Venue.
- f. If the bid is submitted without or less or not in required type the bid security deposit.
- g. If the bidder has previous bad experience with NRSP.
- h. It is received after expiry of the due date and time stipulated for Bid submission.
- i. Incomplete Bids, including non-submission or non-furnishing of requisite documents / Conditional Bids / Bids not conforming to the terms and conditions stipulated in this tender document are liable for rejection by the NRSP.

24. Modifications and Withdrawal of Bids

Bids once submitted will be treated, as final and no further correspondence will be entertained on this.

- a. No bid will be modified after the deadline for submission of bids.
- b. No bidder shall be allowed to withdraw the bid, if the bidder happens to be a successful bidder.

25. Bid Opening and Evaluation

- a. The Purchaser will open the bids, in the presence of Bidder's representative(s) who choose/authorized to attend, at the time and date mentioned in Bid document at the address mentioned at bidding details.
- b. The bidder's representatives who are present shall sign the sheet evidencing their attendance. In the event of the specified date of bid opening being declared a holiday for Purchaser, the bids shall be opened at the appointed time and place on next working days.
- c. Bidders satisfying the technical requirements as determined by the Purchaser and accepting the Terms and Conditions of this document shall be short-listed.
- d. Decision of the Purchaser in this regard shall be final and binding on the bidders.
- e. The contract will be awarded only to the successful responsive bidder.
- f. NRSP reserves the right to negotiate with Second, third bidder etc. if successful bidder is not able to supply the deliverables and his bid security will be forfeited.

26. Clarifications of Bids

To assist in the examination, evaluation and comparison of bids the Purchaser may, at its discretion, ask the bidder for clarification. The response shall be in writing and no change in the substance or price of the bid shall be sought, offered or permitted.

27. Purchaser's Right to Accept or Reject Any Bid or All Bids

The Purchaser reserves the right to accept or reject any bid and annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the ground for the Purchaser's action.

28. Governing Laws and Disputes

All disputes or differences whatsoever arising between the parties out of or in relation to the meaning and operation or effect of these Tender Documents or breach thereof shall be settled amicably. If however the parties are not able to solve them amicably, the same shall be settled by arbitration in accordance with the applicable Pakistani Laws, and the award made in pursuance thereof shall be binding on the parties. The Arbitrator/Arbitrators shall give a reasoned award.

29. Placement of Order and Acceptance

The vendor shall give acceptance of the order placed on it within 3 days from the date of order, failing which, the Purchaser shall have right to cancel the order.

30. Authorized Signatory

The bidder should indicate the **authorized officials from their organization** who can discuss, correspond, sign agreements / contracts, raise invoice and accept payments and also to correspond. The bidders should **furnish proof of signature of the authorized personnel** for above purposes *as* required by the NRSP.

31. Appeals

Bidders believing that they have been harmed by an error or irregularity during the award process may file a complaint to NRSP at complaints@nrsp.org.pk.

- d. Will treat all confidential NRSP information appropriately; will take reasonable steps to prevent access to confidential information by unauthorized people and will not take advantage of proprietary or privileged information, for use by them or others, without the NRSP's permission.
- e. Will avoid conflicts of interest, or the appearance of such, and will disclose to NRSP immediately any circumstances or interests that they believe may influence their work, judgment or objectivity.
- f. Will not contact NRSP during the any pre-solicitation or evaluation phase in which participated, unless NRSP contact for any information.
- g. Will offer to withdraw from agreement when they believe their objectivity or integrity may be impaired.
- h. Will inform NRSP immediately if there is any change in contact person, email, address, directors, release of any of his/her employee or any such information which could be necessary for NRSP record.
- i. Will represent the profession with integrity and professionalism in their relations with NRSP, colleagues and the general public.
- j. Will report to appropriate authorities within or external to NRSP organization any occurrences of malfeasance, dangerous behavior or illegal activities discovered during the course of an agreement.
- k. Will not offer commissions, gift, bribe, remuneration, or other benefits from himself or from a third party in connection with any agreement to NRSP, and will disclose in advance any financial interests.
- l. Will promote adherence to the Code of Conduct and Ethics by all other staff working on their behalf.
- m. Strive to treat all persons of NRSP with respect and courtesy in accordance with applicable international and national conventions and standards of behavior;
- n. Never intentionally commit any act or omission that could result in physical, sexual or psychological harm to the beneficiaries we serve, or to their fellow workers;
- o. Not condone or intentionally participate in corrupt activities or illegal activities. While respecting and adhering to these broader frameworks of behavior,
- p. Shall not harass, discriminate, or retaliate against any other consultant/vendor or any member of society.
- q. Shall make themselves available and fully participate in all administrative inquiries with completely honesty.
- r. No NRSP employees shall solicit anything of value from a citizen or business for services that the NRSP is expected to provide.
- s. Shall not remove NRSP property from its assigned place for personal use. Defacing or destroying NRSP property is vandalism and shall be dealt strictly.
- t. Will not permit considerations of race, gender, nationality, religion, politics, sexual orientation or social status to influence professional behavior or advice.
- u. Will be respectful of those whose wellbeing may be contingent. Will diligently apply objective judgment to all consulting agreements, based on the best information available. Will conduct independent research and analysis where possible, and will consult with colleagues and others who can help inform the judgment.
- v. Will not use any services, goods, materials, technology and/or equipment provided by or paid for by NRSP for illegal, inappropriate, or otherwise disruptive activities, or in support of such activities.
- w. Shall not place or display non-official notices in NRSP premises without prior written approval from the appropriate authority.
- x. Shall not possess unauthorized weapons, illegal drugs, or alcohol on NRSP premises.
- y. Shall strictly follow the NRSP's workplace policies while on any NRSP premises.

This Code of conduct is not exhaustive and may not anticipate every situation which may morally, ethically, professionally, legally compromise the employees or NRSP interests. In this regard NRSP expects to use sound judgment. However, compliance with this Code is a mandatory obligation owed by all consultants, third party vendors etc. Breach of this Code or any requirements mentioned in these Rules will result in disciplinary action and may lead up to cancellation of work order/registration including legal action or other appropriate disciplinary actions.

Anti-Money Laundering and Anti-Terrorism Financing Policy

Policy

"It is the policy of the NRSP to prohibit and actively prevent money laundering and any activity that facilitates money laundering or the funding of terrorism or criminal activities" by complying with all applicable requirements under the **Anti-Money Laundering Act 2010** (Act No. VII of 2010 - an Act to provide for prevention of money laundering) and **Anti-Terrorism (Second Amendment) Act, 2014** and its implementation regulations. Recently under the national action plan and SECP regulations money laundering has been identified as a major cause for corruption and criminal activities. Therefore, NRSP is very sensitive to ensuring that our platform is not used for any such purposes.
