## 1. Introduction

Established in 1991, NRSP is the largest Rural Support Programme in the country in terms of outreach, staff and development activities. It is a not-for-profit organization registered under Section 42 of Companies Ordinance 1984.

NRSP's mandate is to alleviate poverty by harnessing people's potential and undertake development activities in Pakistan. It has a presence in 56 Districts in all the four Provinces including Azad Jammu and Kashmir through Regional Offices and Field Offices. NRSP is currently working with more than half a million poor households organized into a network of more than 115,076 Community Organizations. With sustained incremental growth, it is emerging as Pakistan's leading engine for poverty reduction and rural development.

## 2. Background

National Rural Support Programme is implementing a project titled “ HerWASH: Improved adolescent health of rural women and girls in District Thatta” funded by Water Aid in Pakistan.

Through this project of ‘HerWASH: NRSP and Water Aid will intervene to improve the menstrual hygiene of adolescent girls and MWRAs.

In order to ensure the access of women the 9 gender sensitive toilets (Women friendly toilets) will be rehabilitated/improved at four following location public offices/locations:

- I. Civil Hospital Thatta, (5 toilets)
- II. Taluka Education Office Thatta (1 toilet),
- III. Director Social Welfare Office Thatta (2 toilet) &
- IV. Government Vocational Training center (Girls) Thatta (1 toilet)

The proposed rehabilitation work aims to improve the menstrual hygiene management (MHM) for women and adolescent girls. Improved MHM will be achieved through increasing government and civil society responsiveness to the menstrual hygiene needs of women and adolescent girls, as well as through increased utilization of MHM friendly facilities, and product supplies in schools, healthcare centers, public facilities/places and communities. . The Toilets are located in Thatta city having limited access to WASH specially MHM services.

## 3. Procurement Items

NRSP is in process of procuring material & labour services for Improvement/rehabilitation of toilets at four locations in Thatta city under WASH4Work component of HerWASH project from Firms who are technically & financially strong and have ability to rehabilitate/improve the toilets as per the BoQ & Drawings as per Annex-B & Annex-C and terms & condition given below: -

## 4. Submission of Bid

- 4.1. Bid with technical specifications and rates of the offered items should be submitted in single sealed envelope.
- 4.2. Bid should be submitted separately for procurement of Material and labour services separately.
- 4.3. Prices should be inclusive of all applicable taxes
- 4.4. Prices shall include transportation and other related costs till the destination which **are given in section 2, District Thatta.**
- 4.6. Toilets need to be constructed/rehabilitated by the bidder at the designated sites as mentioned above in para 2 as per the required specifications provided in Annexure B & Annexure C
- 4.7. The bidders should take care in submitting the bid and ensure that enclosed papers are not found loose and should be **properly numbered** and submitted in a file in proper manner so that the papers do not bulge out and tear during scrutiny.
- 4.8. **Last Date of Submission is 10<sup>th</sup> May, 2022 till 3:00 pm local time.**
- 4.9. The bids to this tender must be submitted no later than 10<sup>th</sup> May, 2022 till 3:00pm local time as per format specified in **Annex A** to the point of contact given above. Electronic bids will not be entertained. Any bids delivered after due date and time will be considered non-responsive and disqualified from further consideration.

- 4.11. The purchaser reserves the right for conducting pre-shipment inspection by its own personnel or reputed third parties. The selected bidder has to offer the items for inspection in such a manner that it does not affect the delivery schedule.
- 4.12 The offer should remain **valid for a period of 30 days** from the closing date of the Commercial Bid. Any offer falling short of the validity period is liable for rejection. However, the vendor should pass on the benefit to the purchaser if there is any price reduction in the meantime. If a bidder extend bid validity period then will also extend the bid security period.

4.13 The vendor may withdraw its offer after its submission, provided that written notice of withdrawal is received by the purchaser prior to the closing date and time prescribed for submission of tender documents. No offer can be withdrawn by the vendor subsequent to the closing date and time for submission of offers.

## 5. Eligibility of the Bidder

Firms having valid NTN and having valid PEC registration in at least Cat C6 are Eligible to participate in this tender.

## 6. Deliverables

Rehabilitation/Improvement of Toilets as per as per details given in section 3 within 3- month time after issuing of work order to the successful bidder.

## 7. Terms of Bid

### 7.1. Bid Security.

All bidders shall furnish Security Deposit of Rs. 40,000 in the form of Call deposit/Pay Order/Demand Draft in favor of NRSP. Cheque will not be accepted in any case. After selection of successful bidder, NRSP will return/release the bid security to the unsuccessful bidders.

## 8. Submission of Bid and required Documents

- 8.1. The Bid should comply with the technical specification required of the items as specified section 3. The offer should be complete in all respects and contain all information asked for, with prices The Technical Bid must be organized neatly and securely in the following manner.
  - 8.1.1. Covering letter as per **Annex A**.
  - 8.1.2. Technical and Financial bid in details with terms and conditions on Firms original letter head duly signed and stamped.
  - 8.1.3. Undertaking on Rs.100/- stamp paper duly attested by notary public as per attach format as Annex C.
  - 8.1.4. Bid Security in the required type of bank instrument.
  - 8.1.5. Copy of NTN certificate of the Firm must be attached.
  - 8.1.6. Copy of valid PEC registration certificate must be attached.
- 8.2. If the Bid is not submitted in the prescribed formats or any of the item in the as mentioned above, the Bid is liable for outright rejection.
- 8.3. Once the bid is submitted in sealed cover by the bidder, the purchaser will not accept any addition / alterations / deletions of the Bid. However, the purchaser reserves the right to seek clarification

or call for supporting documents from any of the bidders, for which the concerned bidder will need to submit the documentary evidence(s) as required by the purchaser.

- 8.4. Any Bid, submitted with incorrect information will be liable for rejection. Further, if any bidder is found to have submitted incorrect information at any time, he may be debarred from participation in the future tendering process.

## 9. Evaluation Criteria for Bid

- 9.1 The Purchaser will scrutinize the offers to determine whether it is complete, whether errors have been made in the offer, whether required technical documentation has been furnished and whether the documents have been properly signed. Offers with incorrect information or not supported by documentary evidence, wherever called for, would be summarily rejected. However, the purchaser, at its sole discretion, may waive any minor non-conformity or any minor irregularity in an offer. The Purchaser reserves the right for such waivers and this shall be binding on all vendors.
- 9.2. Evaluation criteria will be **Given Specifications, Quality, Price and Delivery time respectively of the items**. Deviation from specifications stipulated may make the offer liable for rejection.
- 9.3. For proper scrutiny, evaluation and comparison of offers, the purchaser may, at its discretion, ask some or all vendors for clarification of their offer. The request for such clarifications and the response will necessarily be in writing.
- 9.4 The Bids will be evaluated for jointly for supply of material & labour . Supplier would be selected on the basis of overall lowest offer for both material & labour.

## 10. Fees and payment Schedule

- 10.1. No advance will be allowed.
- 10.2. Payment will be made after the complete and satisfactory delivery/acceptance of the works completed at designated site/destinations within 3-Months through cross cheque or mutually agreed.
- 10.3. Partial payment is allowed as mutually agreed in the contract
- 10.4. Withholding tax and GST will be deducted from all the invoices as per prescribed law of Govt. of Pakistan.
- 10.5 Tax challan will be provided within 3-4 weeks of the payment. In case of any tax exemption, valid certificate must be attached

## 11. Paying Authority

The payments as per the Payment Schedule covered hereinabove shall be paid by NRSP. However, Payment

of the Bills would be payable on receipt of advice/confirmation for satisfactory work from, project Engineer & Project Manager. Partial payment is allowed.

Following Documents are to be submitted for Payment:

1. Invoice of the material supplied and labour service provided on rehabilitation of toilets as per actual on site.
2. Tax Documents
3. MB for the work done
4. Picture of completed work
5. Material Received Note (MRN)/GRN (if applicable).
6. Comparative statement with at least three quotes of material supplied & labour services provided for Non BOQ items duly approved by NRSP.

## 12. Delivery Schedule

The Selected Bidder must undertake to provide material and labour services for rehabilitation of toilets in project district of within three month from the date of the Work Order/contract. However, Delivery schedule may be changed under special circumstances at the discretion of the Purchaser.

## 13. Penalty for Downtime

In case of delay in the supply of material against the terms indicated in the purchase order, the Vendor will have to pay a fine of 0.5 % (Half) percent of the balance qty for each day of delay. If shipment is delayed for more than 7 days the Purchaser has the right to unilaterally cancel the contract.

## 14. Penalty on Liquidated Damages for delayed supply

In case the delivery is delayed beyond the stipulated date of delivery, 'Liquidated damage for late delivery @ one half of one percent (0.5%) of the order value for each day of delay or part thereof would be imposed, subject to maximum of 10% if the delay is for 10 days or more. The penalty for late delivery will be deducted from the bill amount.

## 15. Bid Currency

All prices shall be expressed in Pakistani Rupees only.

## 16. Cost of Bidding

The bidder shall bear all the costs associated with the preparation and submission of bids & samples and NRSP will in no case be responsible or liable for these costs regardless of the conduct or outcome of the bidding process.

## 17. Bidding Document

The bidder is expected to examine all instructions, forms, Terms and Conditions and specifications in the Bidding Document. Submission of a bid not responsive to the Bidding Document in every respect will be at the bidder's risk and may result in the rejection of its bid without any further reference to the bidder.

## 18. Deadline for Submission of Bids

Bids must be received by the Purchaser at the address specified in the Bid Document not later than the specified date and time as specified in the Bid Document. In the event of the specified date of submission of bids being declared a holiday for the Purchaser, the bids will be received up to the appointed time on next working day.

The Purchaser may, at its discretion, extend this deadline for submission of bids by amending the bid documents.

## 19. Confidentiality Statement

All data and information received from NRSP for the purpose of this assignment is to be treated confidentially and is to be used ONLY in connection with the execution of these Terms of Reference. All intellectual property rights arising from the execution of these Terms of Reference are assigned to NRSP. The contents of written materials obtained and used in this assignment may not be disclosed to any third parties without the expressed advance written authorization of NRSP.

NRSP may then disclose the draft, final report and/or any related information to any person and for any purpose they may deem appropriate.

## 20. General Terms & Conditions

- 20.1. The Purchaser **does not bind** itself to accept the lowest or any Bid and reserves the right to reject any or all Bids at any point of time prior to the issuance of purchase order without assigning any reasons whatsoever.
- 20.2. NRSP have the right to split the order in two or more suppliers.
- 20.3. The **NRSP** reserves the right to resort to **re-tendering without providing any reason whatsoever**. The **NRSP** shall not incur any liability on account of such rejection.

- 20.4. The **NRSP** reserves the right to **modify** any terms, conditions or specifications for submission of offer and to obtain revised Bids from the bidders due to such changes, if any.
- 20.5. **Canvassing** of any kind will be a disqualification and the **NRSP** may decide to cancel the bidder from its empanelment.

## 21. Rejection of the Bid

The Bid is liable to be **rejected** if:

- The document doesn't bear signature of authorized person.
- It is received through Telegram/Fax/E-mail.
- If only Technical or only financial offer is received.
- If the bid is submitted without or less or not in required type the bid security deposit.
- It is received after expiry of the due date and time stipulated.
- Incomplete bid, including non-submission or non-furnishing of requisite documents/Conditional Offers not conforming to the Terms and condition stipulated in this tender document are liable for rejection by Purchaser.
- If any of the information provided is found incorrect/false or misleading.

## 22. Modifications and Withdrawal of Bids

Bids once submitted will be treated, as final and no further correspondence will be entertained on this.

- No bid will be modified after the deadline for submission of bids.
- No bidder shall be allowed to withdraw the bid, if the bidder happens to be a successful bidder.

## 23. Bid Opening and Evaluation

- The Purchaser will open the bids, in the presence of Bidder's representative(s) who choose/authorized to attend, at the time and date mentioned in Bid document at the address mentioned at bidding details.
- The bidder's representatives who are present shall sign the sheet evidencing their attendance. In the event of the specified date of bid opening being declared a holiday for Purchaser, the bids shall be opened at the appointed time and place on next working days.
- Bidders satisfying the technical requirements as determined by the Purchaser and accepting the
- Terms and Conditions of this document shall be short-listed.
- Decision of the Purchaser in this regard shall be final and binding on the bidders.
- The contract will be awarded only to the successful responsive bidder/s.
- NRSP reserves the right to negotiate with Second, third bidder etc. if successful bidder is not able



to supply the deliverables

## 24. Clarifications of Bids

To assist in the examination, evaluation and comparison of bids the Purchaser may, at its discretion, ask the bidder for clarification. The response shall be in writing and no change in the substance or price of the bid shall be sought, offered or permitted.

## 25. Purchaser's Right to Accept or Reject Any Bid or All Bids

The Purchaser reserves the right to accept or reject any bid and annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the ground for the Purchaser's action.

## 26. Governing Laws and Disputes

All disputes or differences whatsoever arising between the parties out of or in relation to the meaning and operation or effect of these Tender Documents or breach thereof shall be settled amicably. If however the parties are not able to solve them amicably, the same shall be settled by arbitration in accordance with the applicable Pakistani Laws, and the award made in pursuance thereof shall be binding on the parties. The Arbitrator/Arbitrators shall give a reasoned award.

## 27. Authorized Signatory

The bidder should indicate the **authorized officials from their organization** who can discuss, correspond, sign agreements / contracts, raise invoice and accept payments and also to correspond. The bidders should **furnish proof of signature of the authorized personnel** for above purposes *as* required by the NRSP.

## 28. Appeal.

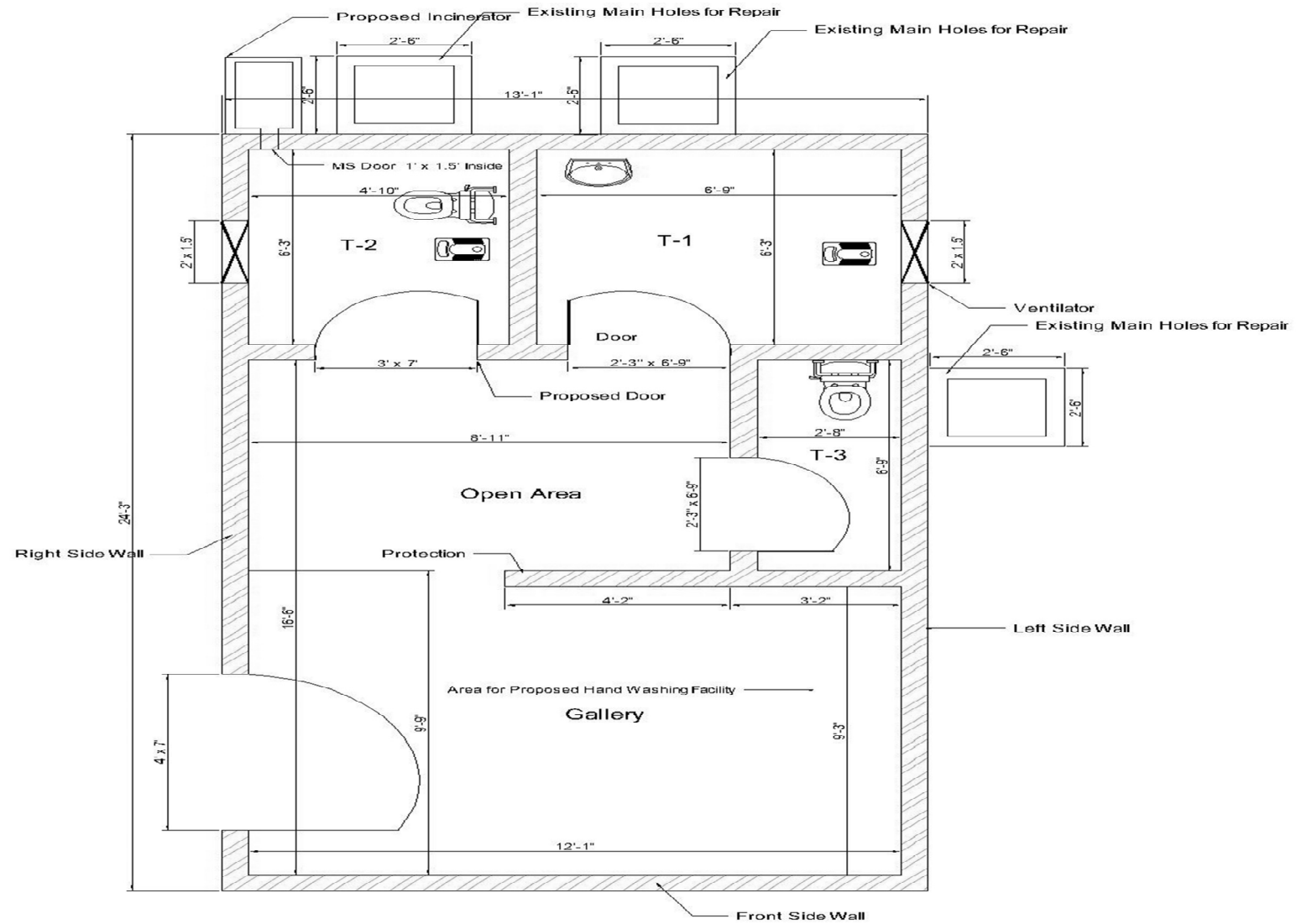

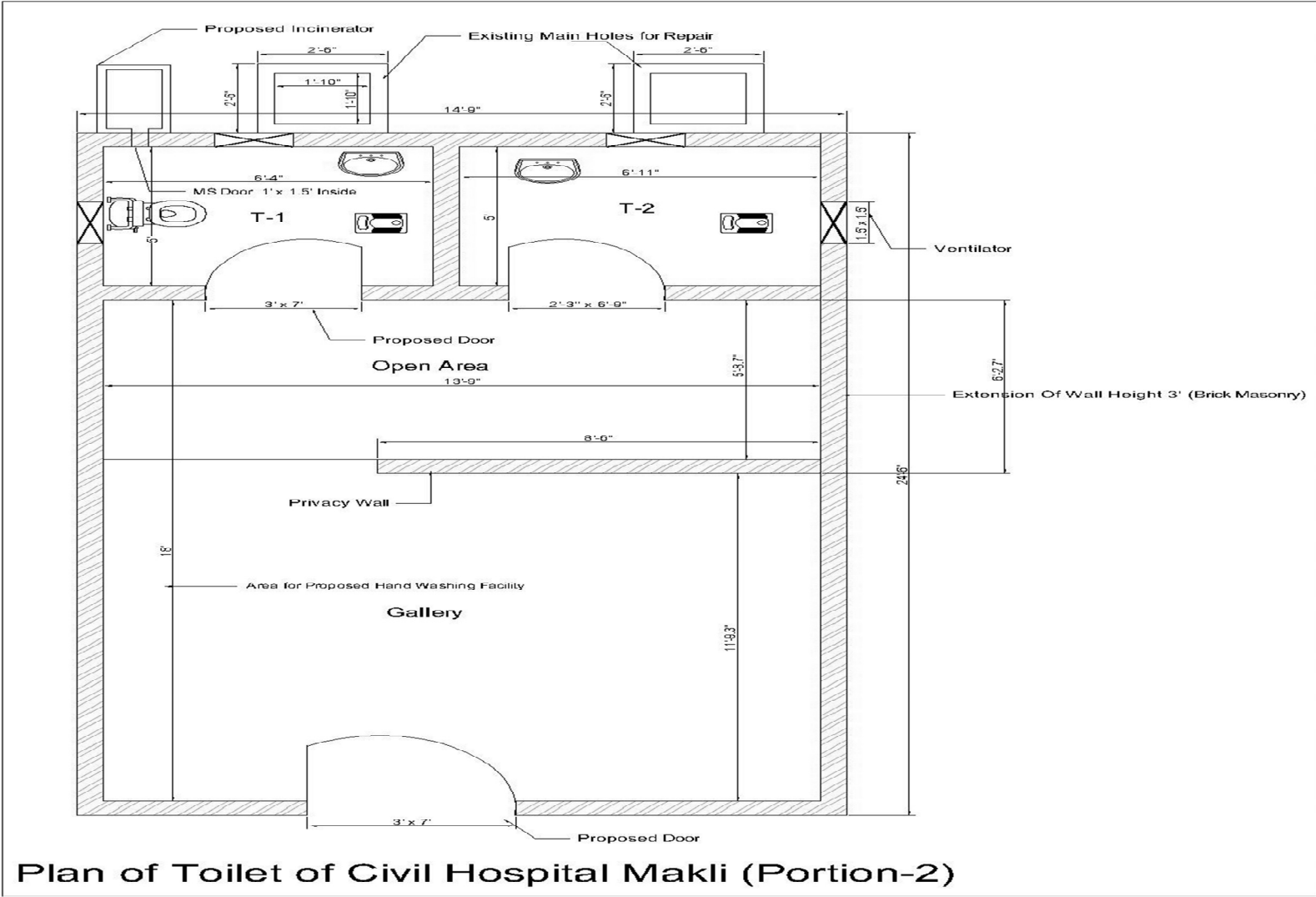
#### Site 01(Portion-1): Rehabilitation Plan of Latrine



### Plan of Toilet of Civil Hospital Makli (Portion-1)



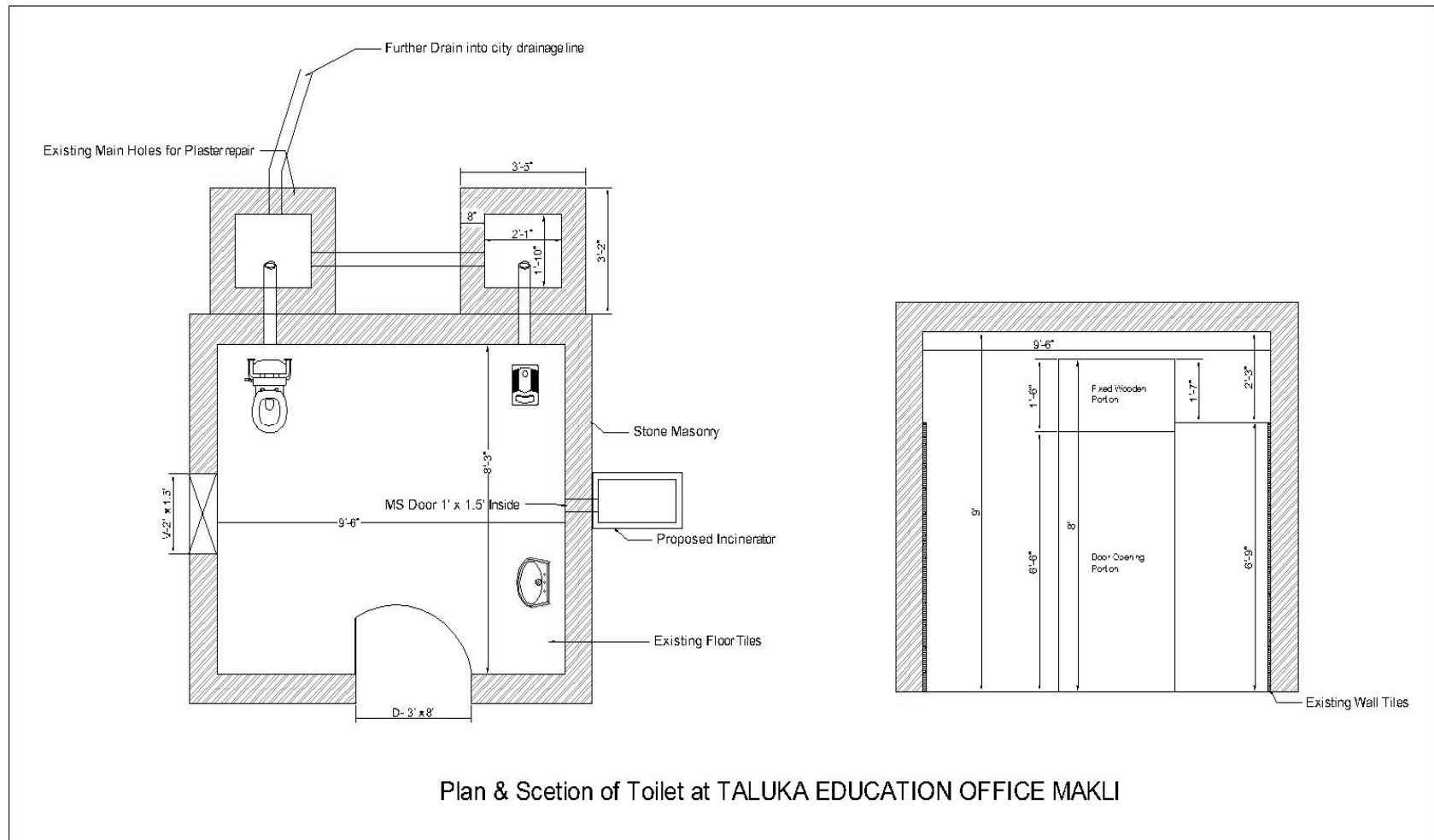

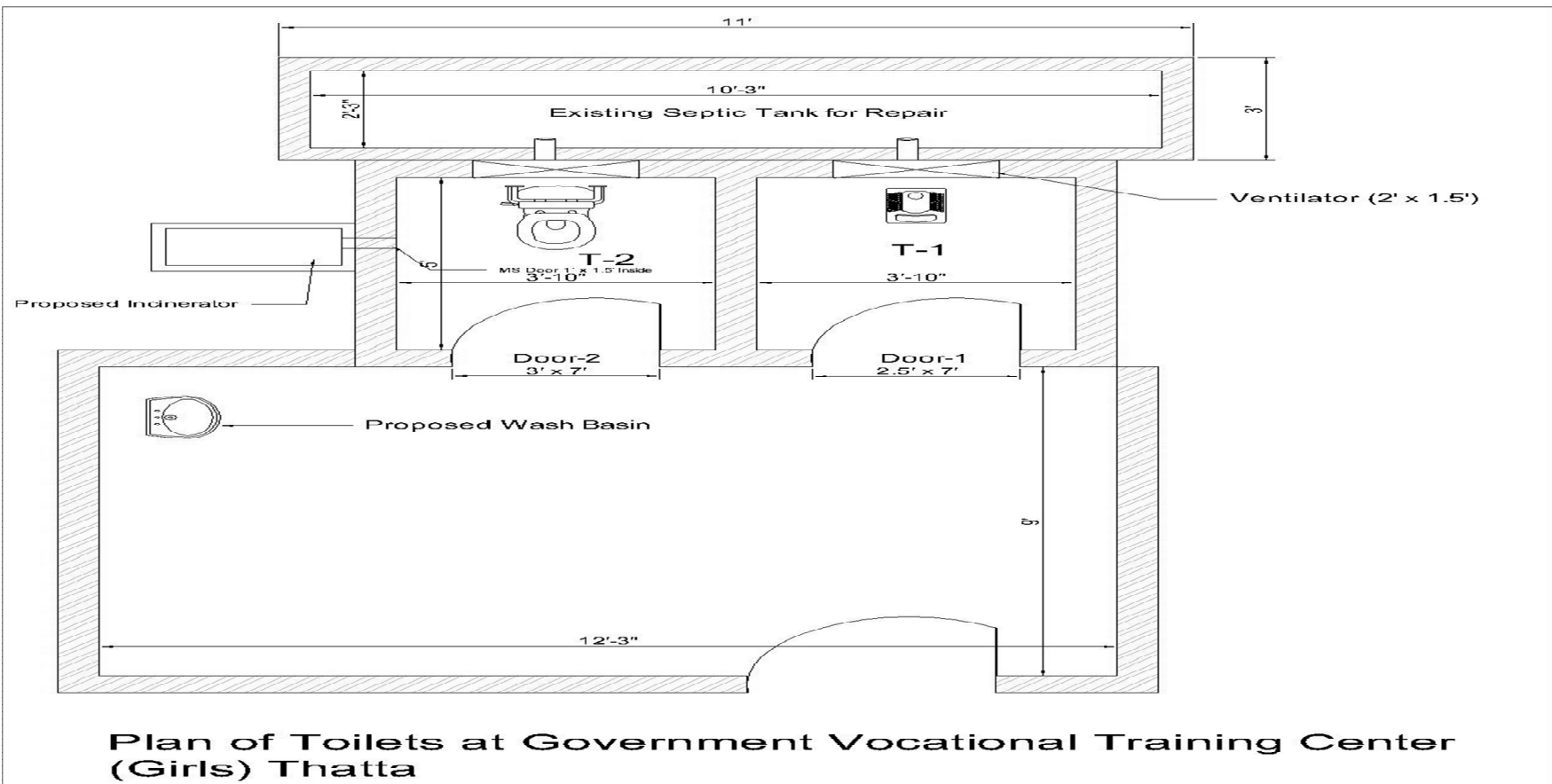

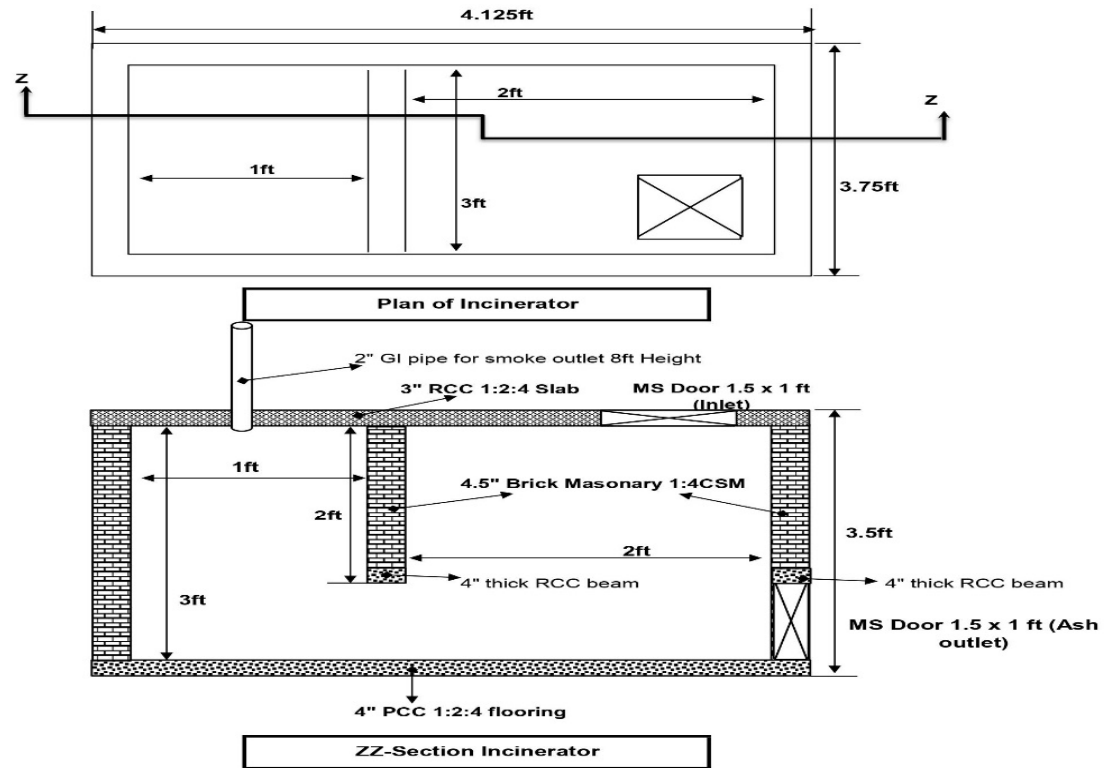

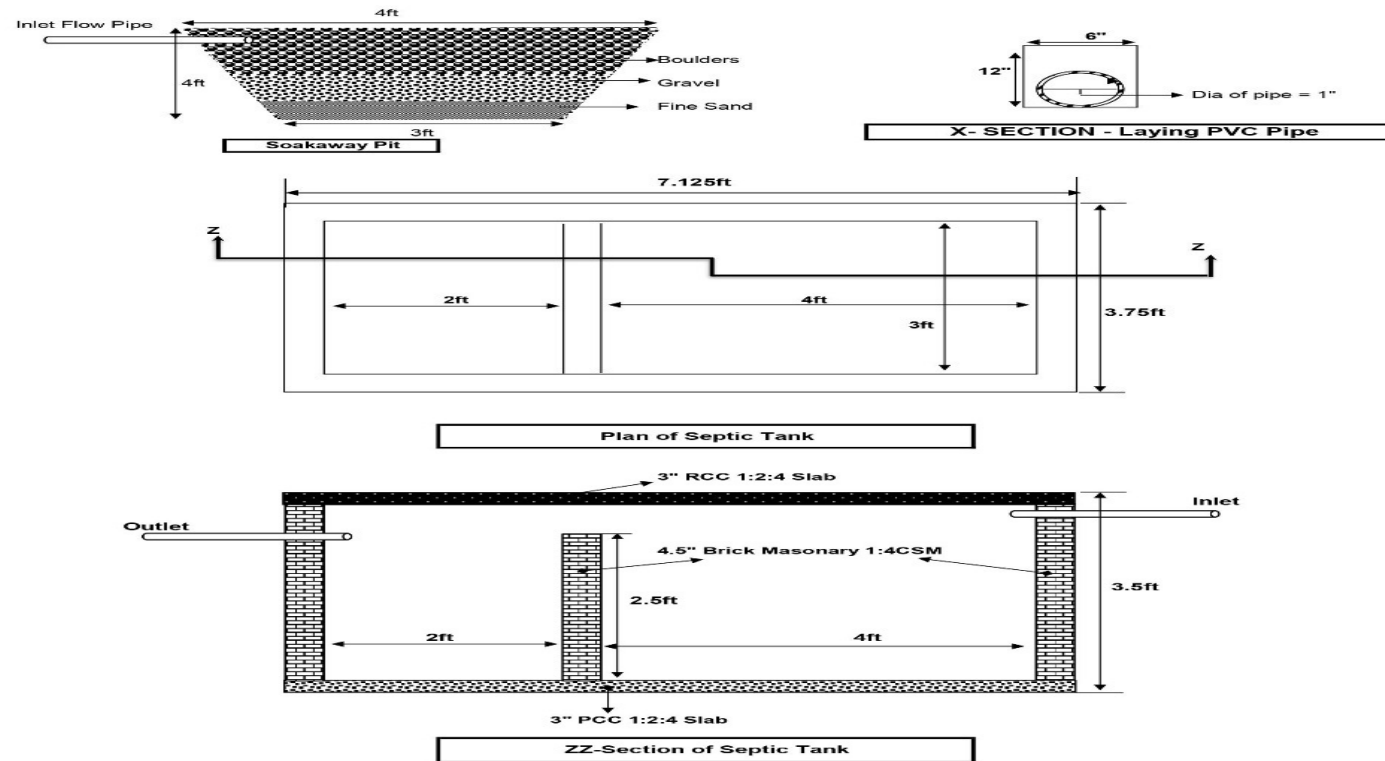

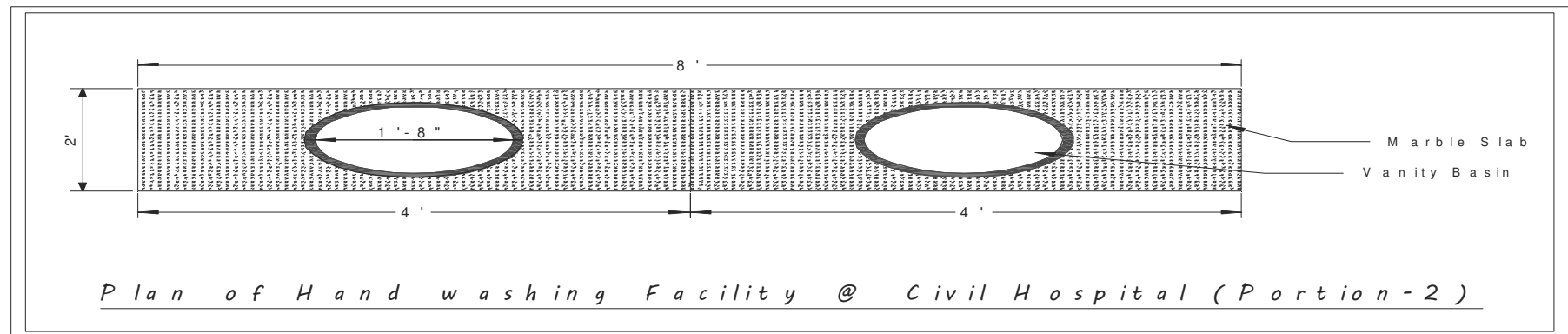
