You may detect a 5% security deposit from running or full bills as practiced by the provincial & federal Authority.	The Performance security would be 10% of the total order/contract value which need to be submitted after issuance of letter of award in the shape of Pay order/Call Deposit/Demand draft and will be released once the suppliers complete the delivery of ordered kit(s) successfully within the given time.
